#### **Aim of The Course**

This course is the continuation of the International Legal Order, and the topics covered are closely linked with the earlier course. The main objective of the course is to present basic concepts of public international law to the students and to help them in developing skills in analysis of relationship between law and international society. The topics related to the law of the sea will cover a significant portion of the second semester together with the law of warfare. Legal tools for a peaceful settlement of disputes will be another key focal point of the course.

#### **Course Outcomes**

Upon completion of this course, the student should:

- 1. Have an understanding about the interaction among the members of the international society
- 2. Be familiar with the concepts of international legitimacy as well as dynmism embedded in it
- 3. Have an understanding about what the functions that legality plays in international order and stability.
- 4. Develop a sense about the sea and how it differs from the law of the land
- 5. Be familiar with the concept of state acquisition and state succession
- 6. Understand the general rules about international treaties and how to terminate them
- 7. Devise different tools to solve international controversies in a peaceful manner
- 7. Develop a critical stance toward the issue of self-determination

### Method

The course is mainly based on in-class lectures. The professor may make references to milestone cases. Questions and exercises from the textbook, Power Point presentations, as well as student experiences and responses will also be an integral part of teaching.

#### **Attendance Procedure**

#### **Evaluation Methods and Tools**

However, as the subjects complete each other, students are encouraged to make frequent references to the previous topics when they are answering the questions.

In addition to midterm and final exams, the professor may ask 'bonus' questions during the classes in order to raise student attention and reduce exam stress. There will be a 10 question online quiz after each chapter. Top ten students will be awarded 1-10 points that will be added on midterm or final scores.

## **Assignments**

Assignments are given only a few students who are eager to receive higher grades. So, it will ve competitive. Assignments, to be completed as short presentations, should not contain errors in spelling, punctuation, style, etc. Dictionaries, spellcheckers, and other methods of checking and proofreading are encouraged. Incorrect assignments may be returned to be rewritten. Most assignments submitted must be keyboarded. Due dates of assignments will be announced in advance.

Grading is as follows: Ten points will be deducted for each major error; points of lesser value will be deducted for less critical errors.

# **Class Participation and Homework**

Students are encouraged to ask questions to clarify understanding and to discuss and debate the theories, principles, and concepts from the text, case studies, and lectures. Students will be expected to participate in class and will be called upon on a regular basis.
